1. Key policy areas for the GHA to consider and biggest challenges in tackling gambling related harm

# **Gambling and Sports**

- De-normalisation of gambling in sporting culture
- Gaming and gamification of gambling
- Improving awareness/ educating healthcare professionals and the wider public health workforce to assess for signs of gambling related harm
- Learning from international experience e.g. Italy ban on football, Australia
- Learning from other public health interventions

## <u>Online</u>

Online gambling and gaming

- Loot boxes, Fifa packs, in app and in-game purchases
- Inconsistency in legislation loot boxes aren't classed as gambling and therefore regulated.

#### Access to data

- Access to data from the Ministry of Defence
- To what extent are Commissioners requesting data on gambling related harms?

### Narrative around gambling

- Responsible gambling including how the responsible gambling concept started as the 'responsible provision of gambling' and has now gradually shifted towards to the individual being responsible for their activity, in the process also implying that those experiencing gambling—related harms are at fault for experiencing harms.
- Language and the way that gambling is framed/ defined; the move away from discussing 'problem gambling' toward 'gambling related harm'

### Regulation and the system

- Calls for a compulsory levy
- The role of Gamble Aware
- Make changes to the gambling system including structural reform
- The role of the gambling commission in commissioning healthcare services
- Gambling not labelled as this by gambling companies e.g. the lottery should be called gambling
- Where should voluntary settlements sit currently with industry, should be with HMT

#### Other areas

- The role of material/social inequalities in influencing someone's likelihood to gamble.
- The use of algorithms and how they could be used as a force for good
- How to better protect children and young people
